The TransAlta Tri Leisure Safety Committee has a safety and emergency plan for:

- The general safety of athletes, competition personnel and spectators during the competition.
- The Tri Leisure Centre has trained lifeguards and emergency procedures in place in the event of a minor or major incidents involving injury or illness to competitors, competition personnel and spectators.

The following overview will outline the facility that will be utilized during the Candy Cane Meet. It will clearly identify those authorized persons to initiate the Safety and Emergency Plan and outline command and control functions.

General procedures can be found in the Tri Leisure Standard Operating Guide, in conjunction with Alberta Legislation and Regulations pertaining to pool operations.

Major-Minor Incidents:

2024-11-19

The Tri Leisure Centre Aquatic facility staff will notify the appointed Safety Officer of any major incident that occurs on site including any drowning, resuscitation, suspected spinal injury and possible fracture.

The Tri Leisure Centre Aquatic area will be supervised by certified Lifesaving Society National Lifeguards employed by the Tri Leisure Centre. Employees will deal with emergencies as per the Tri Leisure Centre emergency procedures. The Candy Cane Meet management committee will assist with managing the participants and volunteers during an emergency.

Medical Facilities:

2024-11-19

On Site Service

All minor first aid services can be provided within the Tri Leisure Centre aquatics area. It is at the discretion of the Tri Leisure Centre emergency procedures as to whether a patient should be transported to a facility off-site.

Code of Conduct:

2024-11-19

All volunteers, officials, competitors, and coaches shall adhere to the Codes of Conduct outlined in the most recent printing of the AB/NWT Competition Manual. The Candy Cane Meet Committee will be responsible for enforcement of these codes. Anyone not adhering to the safety procedures as prescribed in the most recent printing of the AB/NWT Competition Manual may be disqualified or removed from the property. Unsafe actions and behaviors will not be tolerated.

Safety Officer:

2024-11-19

The Host has a designated Safety Officer. The designated Safety Officer is to liaise with the Tri Leisure Aquatic Centre staff regarding competition safety. The Tri Leisure Aquatic Centre will be required to report and document any incidents that occur at the facility during the event.

Tri Leisure Centre staff will be responsible for initiating the Tri Leisure Centre Emergency Safety Plan.

Contingency Plans:
